**FACTS::**

The appellant Md. Jamaluddin Khan vide his application dt.12.4.2010 forwarded by Hqs. vide letter No.RTI/1(50)/10-11 dt.29.4.2010 and received through RTI Cell, FCI, Zonal Office(East), Kolkata under ION No.RTI/Genl. Corres/Hqs./2010 dt.10.5.2010 had sought certain information on 5(five) points as contained in his application. On the basis of his application, he was given reply vide this office letter of even No. dt.28.05/02.06.2010 sent through Speed Post to Sri Khan. Now Sri Khan vide his appeal petition dt.07.06.2010 has alleged that he has not received the said reply. Besides, Sri Khan has given his opinions/suggestions on some other matters.

**DECISION::**

I have gone through the appeal of the Appellant and observed from records that in response to his above representation he was given reply vide letter of even No. dt. 28.05/02.06.2010 sent through speed post to him. I find no reason of his allegation for not receiving the said reply. However, since he has alleged that he is not in receipt of the reply, as such a copy of the said reply is again enclosed.

Rest of the contents in his appeal are merely the opinions/suggestions and as no specific information has been sought for, I have nothing to comment.

The appeal petition is disposed of accordingly.

**FACTS:**

The appellant, **Shri Narayan Chandra Ghosh, Manager (QC)** sought for certain information vide his application dated 12.4.2010 received through RTI Cell ION No. RTI/Appl./ZO(E)/2008-09 dated 20.4.2010 which were replied to him vide this office letter No.Estt.3(34)/2008/M(QC) dated 29/30.4.2010 and subsequently forwarded to him by RTI Cell of this office vide No. RTI/Appl./ZO(E)/2008-09 dated 13.5.2010 after collection of reply related to other division of this office.

The appellant has alleged that he has not received any response and being aggrieved he has filed the instant Appeal dated 07.06.2010 incorporating some additional information not included in his earlier application dated 12.4.2010. The said appeal was forwarded by Hqrs. to this office vide No. RTI/1(Misc.)/10-11 dated 16.6.2010 and subsequently received in the Personnel Section vide RTI Cell's ION No.RTI/Appeal/ZO(E)/2008-09 dated 23.6.2010.

**DECISION:**

I have gone through his appeal application and observed that a complete reply was forwarded to him by the RTI Cell of this office vide No. RTI/Appel/ZO(E)/2008-09 dated 13.5.2010 and it is not understood why the same was not received by him. However, since he is not in receipt of the same, as alleged, a copy of the reply of Personnel Divn. bearing number Estt.3(34)/2008/M(QC) dated 29/30.4.2010 forwarded vide letter No.RTI/Appl/ZO(E)/2008-09 dated 13.05.2010 as well as a copy of reply of Vigilance Divn. being ION No. Vig.32(RTI Act)/2009 dated 12.5.2010 is again enclosed.

In respect of the additional information included in the instant appeal, the appellant may apply to the concerned CPIO as per prescribed procedure.

The appeal is disposed of accordingly.

**FACTS:**

The Appellant is a employee of Food Corpn. of India. He sought for certain information vide his application dated 8.10.09 and 16.2.2010 respectively. In all his information he raised questions which was replied to him vide this office letter of even number dated 08.3.2010 and 05.3.2010 citing CIC's decision conveyed through Headquarters Circular No. EP-25-2007-25 (Ref. No.EP-49(1)/2003) dated 24.10.2007 at Paragraph – 3 Sub-para (v) wherein it is mentioned that “answering a question or proffering advise or making suggestion to an applicant is beyond the purview of the Right to Information Act.

Being aggrieved with the reply he has sought for instant Appeal dated 13.3.2010 received through RTI Cell of this office vide ION No.RTI/App.(Bihar)/ZO(E)/2008-09 dated 30.3.2010.

**DECISION:**

I have gone through his above two applications as well as the Appeal petition. It is observed that almost all his queries are hypothetical in nature. Besides, he has raised specific questions/asked reasons for various actions for which, in my opinion, the decision of CIC referred to above is very much applicable.

The appeal is disposed of accordingly.

Sir,

Please refer to your letter dated 23.01.2010 on the cited subject.

In the said letter, you have stated that the letter sent by FCI, ZO(East) on 01.01.2010 in response to your earlier letter dt.13.11.2009 seeking information under RTI Act. contained half and incomplete information.

You have also stated there-in that ZO(E) has not furnished the position of marks which you have scored in Written, G.D. and Interview in the said examination and hence requesting to furnish complete information.

In this connection, it is to inform that in your earlier letter dt.13.11.2009 there were 6(six) queries. Out of which 1 to 4 related to Zonal Office (North) and 5 to 6 related to Zonal Office (E) (copy enclosed). Accordingly, FCI Hqrs. vide their letter No.RTI/1(394)/09-10 dated 25.11.09 forwarded your application to both East Zone as well as to North Zone for providing required information. Based on your above letter dt.13.11.09, you were given reply i.r.of query Nos.5 & 6 specifically meant for East Zone. As such, your contention of providing half and incomplete information is not based on record.

Not only that, the information which you have desired at present vide Point Nos.1 to 4 from ZO(East) that too slightly different from your earlier queries actually meant for Zonal Office(North).

However, point-wise information, as desired at present from Zonal Office (East) are given below for information:-

- 1) You have scored 23.19 in Written Test out of 70;
- 2) You have scored 5.0 in G.D. out of 10;
- 3) You have scored 4.0 in Interview out of 20;
- 4) You have scored all total 32.19 out of 100;
