Sealed item rate tenders are invited for Disposal of Surplus/ Obsolete/ Unserviceable Railway Released Material at FCI Food Storage Depot Dhanbad by the Asstt. General Manager(CE) Regional Office, Ranchi for and on behalf of Food Corporation of India (Quantity 161 MT approx) on " AS IS WHERE IS BASIS" from the interested Licensed Dealers, Govt. Approved Registered Traders/ Authorised agents of MES/Railways/Metal & Scrap Trading Corporation/IRCON/RITES/any PSU of State/ Central Govt. Department , who has executed either (i) One similar completed work costing not less than Rs.25 lakh or (ii) Two similar completed work costing not less than Rs.15 lakh each or (iii) Three similar completed work costing not less than Rs.12 lakh each during last 3(three) years. The tendere are also required to submit Solvency certificate from any Nationalised/Scheduled Bank for monetry limit of Rs.30 Lakh.

Tender documents (non-transferable) containing the terms and conditions can be obtained on payment of Rs. 500.00 only in cash (non-refundable) from the office of AGM (CE), Food Corporation of India, R.O. INVITATION OF TENDER

- 1 Sealed item rate tenders are invited in the prescribed form, for and on behalf of the Food Corporation of India, for Disposal of Surplus/ Obsolete/ Unserviceable Railway released Material at FCI, FSD Dhanbad on "As is where is basis".
- 2 The sale will be carried out in accordance with the attached instructions to the tenderers.
- 3 **Earnest Money:-**
The tender shall be accompanied by the Demand Draft of a Nationalised/ Scheduled Bank drawn in favour of Food Corporation of India, R.O. JHARKHAND, RANCHI for an amount @ 5 % of the total tendered amount. The tenderer shall keep open the offer till such time as may be specified in the tender.
If this tender is accepted, the Earnest Money of 5% deposited by the successful tenderer, will be released after physical completion of work to be recorded by the Engineer-in-charge . The 5% deposited as Earnest Money by other tenderers shall be returned to them but the Corporation shall not be either responsible for any loss or depreciation that may have happened or the Corporation shall not be liable to pay any interest thereon.
Tenders not accompanied with the Earnest Money in proper form shall summarily be rejected.
- 4 Tenders shall be submitted to the Assistant General Manager (CE), Regional Office JHARKHAND, RANCHI in sealed cover superscribed "Disposal of surplus/ obsolete/ Unserviceable Railway Released Material at FCI, FSD Dhanbad . Tenders which get opened before the due date because of covers not having been so superscribed shall be liable to be rejected. The tenders not submitted in prescribed form are liable to be rejected. All annexure should be properly filled and signed by the tenderers.
- 5 Tenders must reach Assistant General Manager (CE), Regional Office JHARKHAND, RANCHI not later than 2.00 P.M. on 30.07.2010 Tender will be opened at 2.30 P.M. on the same day in the presence of tenderers or their representatives . If it become necessary to extend the last date for receipt of tenders, the revised date will be notified. The late tender will not be accepted.
