NOTICE INVITING TENDER

For and on behalf of Food Corporation of India, the General Manager, Orissa, Bhubaneswar invites sealed tenders from contractor(s) having sound financial back-ground and experience in undertaking handling and transport work for appointment as regular H&T contractor(s) for handling of food-grains at ***RAILHEAD, JATNI*** and transportation from ***R.H.JATINI/FSD JATNI/OSWC JATNI/OSWC KHURDA to FSD. BHUBANESWAR or_VICE VERSA*** for a period of two years. Individuals/parties participating in tender shall have to obtain/possess Valid Agents License under Orissa Motor Vehicle (licensing of Agents) Rules, 1990, failing which their tenders will not be considered. The estimated value of this contract is Rs.55,00,000.00 (Rupees Fifty five lakhs only).. The cost of tender form is Rs.1040.00 (Rupees One thousand forty only). E.M.D Rs.1,10,000.00, (Rupees One lakh ten thousand only) and Security Deposit Rs.2,75,000.00 (Rupees Two lakhs and seventy five thousand only). **The offered rate should be inclusive of Service tax, duties and cess etc.** The tender form (non-transferable) containing detailed terms and conditions will be available for sale on any working day from 11.00 A.M to 3.00 PM from **26.07.2010 to 16.08.2010** at Regional Office, Bhubaneswar. The last date for receipt of tender will be on **17.08.2010 up to 3.00 P.M.** The tenders will not be accepted/ admitted after **03.00 P.M.** on **17.08.2010**. The Technical Bids of tenders will be opened on **17.08.2010 at 3.30 P.M.** in the presence of tenderers / their representatives present. E.M.D / Security Deposit shall be accepted in shape of D.D. drawn in favour of Food Corporation of India, Bhubaneswar on any Nationalized /Scheduled Bank payable at Bhubaneswar. Instruments drawn on Bhawanipur Branch of Dena Bank, Kolkata and United Industrial Bank Ltd shall not be accepted towards E.M.D/ Security Deposit. **Tenders received without required documents shall not be considered and liable to be rejected at the initial stage itself.**

The parties resiling before validity period would be black listed and in case of parties not submitting the documents for verification, the Earnest Money shall be also forfeited besides blacklisting him.

There shall be no negotiation except certain exceptional cases and the decision of the General Manager in this regard is final and binding on the tenderers.
